- I. Call to Order** Randy Hawley  
Mr. Hawley called the meeting to order at 4:00 p.m.

- IV. Statement of Welcome** Randy Hawley  
Mr. Hawley welcomed the audience of citizens.
- V. Call to the Public** Randy Hawley  
There were no comments from the audience of citizens.
- VI. Governing Board Member Comments** Board Members  
Ms. McClelland noted she is attending the ASBA Equity Conference next week. The focus will be on adverse childhood experiences and issues, and she will update the board on her return. Mr. Hawley encouraged people to attend Casino Night, a benefit for SRR Scorpions. He also noted that he visited WSS last week and was very impressed with both students and staff. Mr. Hawley stated that the Arizona Republic had an article on the lack of affordable housing in Sedona and encouraged everyone to read it.
- VII. Superintendent's Update** Denny Dearden  
Mr. Dearden hosted the Kachina Retired Teachers Association at the DO last week and shared district initiatives. Feedback was positive, and he noted that the group has a wealth of knowledge and is a valuable tool for the district. Mr. Dearden and Ms. Hermen spoke with ASU Prep to address rumors that they would be opening a school at BP. ASU Prep confirmed that they have no intention of doing this, and stated they are pleased with the direction the district is going in. Mr. Dearden expressed congratulations to all winter sports teams. He attended a superintendents consortium at GCU and shared their impressive marketing strategies for growth. District personnel attended a *Capturing Kids Hearts* seminar and were very impressed with the program. Mr. Dearden thanked the board and admin team for their work on, and support of, the budget for the 19/20 school year. There will be a three-phase transition plan for relocating the district office to the high school. Several recruiting trips are scheduled, and contracts will be issued at the March board meeting.
