The polls will open at 6:00 a.m. and close at 7:00 p.m.

The purpose of the election is to permit the qualified electors of the District to vote on authorizing the District to:

Adopt a General Maintenance and Operation Budget that includes an amount of up to 15% in excess of the revenue control limit for the 2019/2020 fiscal year and for six subsequent years (subject to certain reductions provided by statute in years six and seven). The District's current 15% budget override is by law required to be reduced by one-third in each of 2019/2020 and 2020/2021. Because the existing override reduces by one-third in fiscal year 2019/2020, the proposed 15% override budget will be approximately \$274,488 higher than the District's 2019/2020 alternate budget and the District's secondary tax rate required to fund this amount is estimated to be \$0.05 per one hundred dollars of net limited assessed property valuation. The total budget override amount is estimated to be \$823,464 and would be funded by an estimated \$0.15 tax rate, which is approximately equal to the current tax rate levied for the existing override. In future years the amount of the increase, if any, will be as provided by law.

Los centros de votación se abrirán a las 6:00 de la mañana y se cerrarán a las 7:00 de la tarde.

El propósito de la elección es permitirles a los electores calificados del Distrito votar para autorizar al Distrito a:

Adoptar un Presupuesto General de Mantenimiento y Operación que incluye una cantidad de hasta 15% en exceso del límite de control de ingresos para el año económico 2019/2020 y para los seis años subsiguientes (sujeto a ciertas reducciones estipuladas por estatuto en los años seis y siete). La ley requiere que el sobrepaso del presupuesto de 15% actual del Distrito se reduzca por un tercio en años económicos 2019/2020 y 2020/2021. Debido a que el sobrepaso existente se reduce por un tercio en año económico 2019/2020, el propuesto sobrepaso del presupuesto de 15% será aproximadamente \$274,488 más que el presupuesto alternativo de 2019/2020 del Distrito y la tasa de impuestos secundaria del Distrito requerida para financiar esta cantidad se estima en \$0.05 por cien dólares de valor tasado limitado neto de propiedad. La cantidad total del sobrepaso del presupuesto se estima en \$823,464 y sería financiada por una tasa de impuestos estimada de \$0.15 que es aproximadamente igual a la tasa de impuestos actual exigida para el sobrepaso existente. En años futuros la cantidad del aumento, si la hay, será proveída por ley.
