VIII. Superintendent's Update

Mr. Dearden gave an update of events throughout the district. There are seven new students who have started at the high school this week with several additional tours scheduled. Classes are extremely full, especially at the 8th grade level. An additional teacher with experience in English and Special Education has been hired. She will be used in a variety of ways, including to alleviate large class sizes and help with substitute coverage. Athletics are under way. Middle of year Galileo benchmark testing is ongoing at both campuses. 27 students will be inducted to National Jr Honor Society later this month. A final Arizona Codes grant meeting will be held on January 10. This grant would cover coding classes, teacher training, curriculum and ongoing support. Mr. Dearden is excited about this opportunity as it will prepare students for great job opportunities after graduation. Next year's budget is being developed and will be presented to the board later this month. Finalizing the budget and getting contracts out early is important due to teacher and

housing shortages in the area. The Wildcat Extended Day Program continues to serve elementary school students and has moved to a new dedicated space. Teacher run clubs will begin next Monday.

A. Covid Update

Covid continues to be an issue throughout the community. The CDC has issued new guidelines regarding isolation and quarantine. The school has approximately 160 tests at this time. Tests are regularly administered and positive results are reported to the county.
